SHIPPED SEMEN BREEDING CONTRACT

I hereby agree to breed my mare: _____ Reg. # _____ to the stallion _____, in the year _____, with cooled semen from Crescent View Ranch. I agree to pay an all inclusive fee of \$ _____ (includes breeding fee, chute fee & shipping), made payable to Crescent View Ranch.

1. A booking fee of \$250 must accompany this contract when it is returned to Crescent View Ranch along with a copy of the mare's registration papers. The remaining fee is due at least ten (10) days prior to the request for semen. In the event my mare is not pronounced in foal, I am entitled to reserve one (1) rebreed during the next breeding season. All rebreeds are subject to a \$300 fee the following year.
2. Cooled semen request must be made to Crescent View Ranch before 9:00 a.m. Eastern time one day prior to the anticipated day the shipment is needed in order for the request to be filled that day. Only a licensed veterinarian or technician will receive the semen, open the container and inseminate the above referenced mare.
3. I agree to have my mare pregnancy checked not more than 16 days after breeding and notify Crescent View Ranch of her pregnancy status whether she is in foal or open.
4. Crescent View Ranch will make every attempt to get semen to my mare in good condition, however, will make no guarantees or warranties that the semen will be in good condition upon arrival.
5. I understand that all paperwork sent with the semen must be filled out and sent to the AQHA and Crescent View Ranch.
6. I understand that mares in residence at Crescent View Ranch will be given priority for semen, therefore, there is no guarantee that semen will be available the day of my request.
7. After shipping through 3 heat cycles, Crescent View Ranch reserves the right to request that the mare be sent to a designated veterinarian during this breeding season. Additional shipments are available for a charge of \$150.
8. Is this breeding to be an embryo transfer? YES NO (circle one). Will this mare be bred to the above stallion for more than one embryo? YES NO (circle one). If more than one (1) foal results from any one (1) flush, an additional fee equal to the stallion fee, will be due and payable at the time of requesting the breeders certificate.
9. Crescent View Ranch agrees to ship semen to my mare up to and including July 1, unless otherwise arranged at time of signing of this contract. I further agree to settle her (having bred her through at least three heat cycles). If however, for any reason she does not settle, I will hold Crescent View Ranch and/or the stallion owner harmless.
10. It is my understanding that should the above named stallion die or become unfit for service, or if my mare should die or become unfit to breed, then this contract shall become null and void, and any money paid as part of this service shall be refunded to me.
11. It is agreed that I am guaranteed a live foal at the time of the signing of this contract and that if my foal does not stand and nurse, I will be entitled to a free season the following year to the same mare (unless mutually agreed). This guarantee will apply only if I notify Crescent View Ranch within one (1) week from death of the foal. This notice must be accompanied by a statement from a licensed veterinarian.
12. A breeder's certificate will be issued to me upon notification of the birth of my foal.
13. Semen will only be shipped when the breeding fee has been paid in full and a signed contract along with a copy of the mare's registration papers are on file with Crescent View Ranch.
